

Terms and Conditions: Win a DMOS Shovel

The giveaway is organized by Dutchvanparts, De Hoefkens 6A, Helmond the Netherlands.

All entries must be received between 21:00 on 01/11/2022 and 23:59 on 18/12/2022. One (1) winner in the European Union will be selected at random by The Promoter in week 52 of 2022 and the winner will be notified on or after this date.

The prize of the giveaway is one (1) '[DMOS Stealth Shovel – Aluminum – Powder Coat](#)' in the color 'Racing Red' or 'Punkn Orange'. The winner is allowed to choose between these two colors and these two colors only ('Racing Red' and 'Punkn Orange'). Other colors are not possible. [DMOS Stealth Shovel – Aluminum – Powder Coat](#) is worth €695,- including 21% Dutch VAT. Shipping costs are covered up to €60,-.
